For more than 45 years, the National Association of Counsel for Children (NACC) has strived to serve children and families by supporting a diverse community of legal advocates dedicated to providing high-quality legal representation. NACC has trained tens of thousands of professionals, established an ABA-accredited national certification for Child Welfare Law Specialists, produced pioneering publications — including *Child Welfare Law and Practice* — and steadfastly asserted the rights of children and parents in hundreds of policy statements and amicus briefs in child welfare, juvenile justice, and family law systems.

With our 2019–2023 Strategic Plan, NACC reaffirmed our founding commitment to advance justice, opportunity, and well-being for children and families experiencing the child welfare system. This includes the intersection of the child welfare system with the juvenile and criminal legal systems and family law. - » Delivering timely, frequent, responsive, and updated trainings informed by constituent voice, including presenters with lived experience, and with a focus on diversity, equity, and inclusion
- » Publishing the 4th edition of Child Welfare Law and Practice, utilizing the opportunity to develop the most current and practical resource for practitioners



NACC will **Build Community** by:

- » Increasing support to a growing membership, with a specific focus on increasing diversity and inclusion, and modernizing networking tools and resources for the field
- » Utilizing law school, State Coordinator, and Board partnerships to build community, expand member diversity, and promote the pipeline to and tenure in child welfare law profession
- » Expanding NACC's national conference to diversify attendance, build scholarship fund, and provide high-quality legal education, inspiration, and networking opportunities
- » Leading convenings to advance NACC's policy initiatives

- » Partnering with NACC members and lived experience experts to publish policy papers, assessments of children's right to counsel, amicus briefs, and policy statements consistent with NACC's policy agenda
