- TRAINED 5,000 attorneys, judges and child welfare professionals

## 2021 Impact Report

## NACC Promoted Excellence in Legal Representation

- Delivered training and presentations across 13 states and three national conferences
- Delivered custom trainings in 5 states
- Continued monthly Member Webinar Series, co-designed with lived experience experts
- Obtained recognition from Ohio Supreme Court that Child Welfare Law is a legal specialty
- Certified 43 new CWLS
- Supported the Children's Bureau Capacity Building Center for Courts and Casey Family Programs Judicial and National Engagement Initiatives

Looking ahead, NACC will publish the 4th Edition Red Book and expand training programs with a focus on racial equity and youth engagement.

## NACC Built Community Among Practitioners

- Expanded State Coordinator program to 32 states/ jurisdictions
- Convened over 500 practitioners in Denver and 800 online for our 44th National Child Welfare Law Conference
- Continued Children's Law Office Project meetings, including a pre-conference convening in Denver
- Continued Organizational Membership program, expanding to over 40 organizational memberships after last year's launch



Looking ahead, NACC will host our 45th National Child Welfare Law Conference online and onsite in Baltimore and develop an updated Child Law Office Handbook.

## NACC Promoted Justice for Children and Families

- Launched Counsel for Kids national campaign to ensure the right to counsel for children
- Developed new CounselForKids.org website and state advocacy toolkit
- Joined amicus briefs impacting critical appellate issues such as the Indian Child Welfare Act, right to counsel, and access to the courts
