PROMOTING EXCELLENCE. NACC promotes better outcomes for children and families impacted by the child welfare system by working to ensure lawyers who represent children, parents, and agencies provide high-quality legal representation. NACC trained over 4,000 attorneys and judges in 2022 through an online training course and six custom state trainings developed and delivered by national experts in the field. NACC also certified 27 new attorneys as Child Welfare Law Specialists and published the 4th Edition of Child Welfare Law and Practice books. In 2022, NACC updated its mission, vision, and goals to reflect organizational commitments to race equity.

BUILDING COMMUNITY. NACC builds communities of practice among child welfare legal professionals through our membership program, national conference, and online convenings. NACC convened over 600 practitioners in Baltimore and 500 online for our 45th National Child Welfare Law Conference. NACC's State Coordinator program expanded to 41 states/jurisdictions. NACC also expanded law school engagement, publishing NACC on Campus, a student chapter guide. Additionally, NACC convened and partnered with NACC's National Advisory Council on Children's Legal Representation, a group of young professionals with lived experience in the child welfare system who advise NACC.

PROMOTING JUSTICE. NACC provides a leading national voice on children's legal advocacy. NACC also expanded the Counsel for Kids campaign, website (<https://counselforkids.org>), and advocacy toolkit. Children in court need lawyers of their own. We are working to make sure they have them.

The endowment funds are to ensure the long-term viability and effectiveness of the NACC. The earnings from the endowment may be used by the NACC to fund the ongoing mission of the organization in providing societal justice for children.

NACC retains in perpetuity the original value of unreleased gifts donated to the endowment. Endowment funds decrease upon release of restrictions on gifts by the donor. The restriction placed on the original gift and its accumulated investment earnings from the Lea for Justice Endowment fund was released by the donor in tax year 2018, resulting in a substantial reduction of endowment funds. These endowment funds have remained unspent

and are classified as board-restricted net assets. The accumulated investment earnings have also remained intact.

Part X, Line 2:
