# SHANNON FELDER, JD, CWLS NACC TRAINING DIRECTOR

Shannon Felder joined NACC as the Training Director in February 2024. Shannon earned her law degree from the University of South Carolina School of Law where she was a Carolina Legal Scholar, member of the South Carolina Law Review and President of the Black Law Students Association. Shannon is certified by NACC as a Child Welfare Law Specialist. Shannon is also a member of the South Carolina Bar Children's Law Committee and the South Carolina Black Lawyer's Association.

## **JOSEPHINE VANDERHORST, MFP, JD, CWLS** NACC SENIOR STAFF ATTORNEY

Josephine C. Vanderhorst, MFP, JD, CWLS, joined the NACC in 2024, bringing eight years of dedicated experience in child welfare. Holding a bachelor's degree in psychology from Tuskegee University, a master's degree in forensic psychology from Argosy University, and a JD from Tulane University Law School, she approaches advocacy with a holistic perspective. This multidisciplinary foundation enhances her ability to understand and address the complex needs of children and families within the child welfare system. Josephine's journey began in 2015 at Southeast Louisiana Legal Services, becoming managing attorney in 2020, where she doubled the unit's size and created a transformative multidisciplinary program, hiring the first peer advocate at a children's representation program in Louisiana and a social worker to provide comprehensive support.

### **CALIFORNIA (60-Minute Hour)**
